

# Privacy Policy

## Introduction

Welcome to titanicatlas.com! This privacy policy explains how we collect, use, and protect your personal information. By using our site, you agree to the terms outlined below. This may seem unwarranted for a website like this, unfortunately the [GDPR \(General Data Protection Regulation\)](#) uses very broad definitions, therefore we must formally state out policy on these matters. We will first begin with a few definitions, as described by the GDPR. We will then proceed to provide full information, as required by the aforementioned regulation document.

## Definitions

### Personal Data:

any information relating to an identified or identifiable natural person ('data subject'); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person;

### Data Processing:

any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organization, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction;

### Consent:

any freely given, specific, informed and unambiguous indication of the data subject's wishes by which he or she, by a statement or by a clear affirmative action, signifies agreement to the processing of personal data relating to him or her;

## Data We Collect

- **Personal Data:** We collect your email address when you register an account.

## Data We Process

- **Personal Data:** We use your email address during the account "Sign In", and "forgot your password" processes.
- **Usage Data:** We consult your IP address to further account security, and your device type occasionally, to determine which interface to provide.

## How We Use Your Information

We use your data for the following purposes:

1. **Communication:** To respond to inquiries and provide customer support.
2. **Improvement:** To enhance our website and services.
3. **Authentication:** To verify your credentials when you attempt to sign in and access content.

## **Data Security**

We take appropriate measures to protect your information from unauthorized access, loss, or misuse.

## **Lawful Basis for Processing**

Our lawful basis for processing the aforementioned personal data is **consent**. By registering with, or signing into our site, you consent to our usage of your personal data, solely for the purposes mentioned in previous sections.

## **Consent Mechanism**

We obtain consent through a banner when you first register on our site. In addition we obtain consent through a disclaimer on that appears on the page when the Sign In form is visible.

## **Your User Rights**

Under GDPR, you have rights regarding your personal data. Contact us to exercise these rights.

You have the right to:

- Access your data.
- Correct inaccuracies.
- Request deletion.
